PHILIPPINES - DEFINITIVE SAFEGUARD MEASURES ON TESTLINER

Dear Members,

We were informed by the Philippine Department of Trade and Industry's that definitive general safeguard measures have been imposed on testliner board regardless of grams per square meter (GSM) imported from various countries classified under ASEAN Harmonized Tariff Nomenclature (AHTN).

The measures shall be effective for 3 years starting September 16, 2010, the date the provisional measure took effect.

The definitive general safeguard measure for the first year of its implementation shall be in the amount of (Philippine) Peso 1,342.00/MT subject to an annual review during the remaining years of the implementation period as provided under Sections 13 and 15.3 of RA 8800 and Rules 15.5 and 15.6 of its IRR for purposes of liberalizing or reducing its intensity.

The order shall be effective from the date of the issuance by the Bureau of Customs of the relevant Customs Memorandum Order (CMO) or 15 days after the publication of the DTI Order in 2 newspapers of general circulation, whichever comes earlier.
